

**QUAKER® MUSEUM GIFT CARD PROMOTION AT JEWEL-OSCO
("PROMOTION")
OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING.

1. ELIGIBILITY: Open only to legal residents of the fifty (50) United States and the District of Columbia ("**D.C.**") who are eighteen (18) years of age (nineteen [19] if a resident of Alabama or Nebraska) or older on the date of entry. Void where prohibited by law. Employees, contractors, officers and directors of The Quaker Oats Company ("**Sponsor**"), the independent third-party Promotion administrator TPG Rewards, Inc. 2. PROMOTION PERIOD: The Promotion begins at 12:00:01 p.m. Central Time ("**CT**") on August 22nd, 2022, and ends at 11:59:59 p.m. CT on October 6th, 2022 (the "**Promotion Period**").

3. HOW TO ENTER: During the Promotion Period, go to WWW.QUAKEREXPLORE.COM (the "**Website**") and follow the instructions to complete and submit the registration form (including, but not limited to your personal email address) as requested at the Website. Then follow all prompts and instructions to complete your entry into the Promotion. No responsibility is assumed by Sponsor for lost, late, mutilated, illegible, incomplete, or misdirected email. You will receive one (1) entry into the Promotion drawing associated with your entry.

Limit one (1) entry per person per day during the Promotion Period. For purposes of these Official Rules, a 'day' is defined as any twenty-four (24) hour period during the Promotion Period beginning at 12:00:00 a.m. CT and ending at 11:59:59 p.m. CT.

All entries, regardless of method of entry, must be received in accordance with the deadlines stated herein in order to qualify as an entry into the Promotion. The Website's database clock will be the official timekeeper for entries in this Promotion. In the event a dispute regarding the identity of the individual who actually submitted an entry cannot be resolved to Sponsor's satisfaction, the affected entry will be deemed ineligible. The Promotion Entities shall not be responsible for incorrect or inaccurate entry information whether caused by Internet users or by any of the equipment or programming associated with or utilized in the Promotion or by any technical or human error which may occur in the transmission, receipt or processing of the entries in the Promotion. The Promotion Entities further assume no responsibility or liability for any error, loss, omission, interruption, deletion, theft or destruction, or unauthorized access to, or alteration of entries.

WINNER SELECTION AND NOTIFICATION: On or about October 7th, 2022, fifty potential (50) winners will be selected in a random drawing from among all eligible entries received during the Promotion Period. Potential winners will receive an email and/or phone call within approximately forty-eight (48) hours of the random drawing. If, despite reasonable efforts, a potential winner does not respond within seventy-two (72) hours of the first notification attempt, such potential winner will forfeit his or her Prize and an alternate winner will be selected from among the remaining entries in the drawing pool. The email/phone call will contain further instructions on how to claim the Prize or information regarding the delivery of the prize. If additional information or documents are required to claim the Prize, as stated in the email/phone call, the potential winner must complete the remaining steps of the Prize-claim process.
